You will retain full ownership of information belonging to you.

We do not claim ownership rights on any part of the information in question. This Specification does not provide us with any right of disposition or intellectual property on your information, except for the fulfilment of Services and sharing of your company information with the third-party platforms in which you want this information to be published or broadcast.

The servers ('server') where your operations related to the Website are carried out on and other hardware have firewalls ('firewall') and network security systems of which reliability is constantly being tested. Also, this hardware is run with the most secure software.
